

2015 HIGHLIGHTS



The Fight for Plum Island

Plum Island is an ecological treasure. We issued a notice of intent to sue to the U. S. Department of Homeland Security (DHS) and the General Services Administration, in which we alleged that the agencies had failed to protect endangered and threatened species while pursuing a public sale of the federally-owned island. Last year, we gave many presentations, worked with our partners in the Preserve Plum Island Coalition, and advocated for a conservation solution with Connecticut's and New York's federal delegations. In 2016, as part of congressional action, DHS announced it would perform a study in conjunction with the U.S. Environmental Protection Agency and Department of Interior to identify conservation opportunities and recommend needed changes in law to Congress. We remain committed to bringing suit if the proposed sale is not abandoned.

Restoring Long Island Sound

We filed a case to enforce the Clean Water Act in Westchester County and 11 municipalities—seeking to clean up bacterial contamination and get all responsible parties to the table to reach a long-term solution. We expanded our water quality monitoring program to 12 sites, documenting the presence of fecal bacteria in many harbors and bays in the



western Sound. We launched our Sound Health Explorer, an online tool that shows the public the levels of fecal bacteria and other pollution at their local beaches. We also filed a petition with the U.S. Environmental Protection Agency demanding a broad new program to address the nutrient pollution that is choking Long Island Sound—smothering aquatic life, fueling toxic algae blooms and destroying tidal marshes that protect against flooding and harbor young fish. Early in 2016, the EPA released its comprehensive, new strategy to reduce nitrogen pollution in the Sound.

Climate and Energy

CFE president Donald S. Strait was appointed to the Governor's Council on Climate Change, which was established to keep the state on track to meet the 2020 goals of its Global Warming Solutions Act. The Act puts Connecticut among a handful of states committed to concrete carbon reductions in a specific time frame. We kicked off our Share the Sun Campaign for full-scale shared solar in Connecticut and advocated for Zero Emission Vehicle incentives.



Endangered Lands

Even as we celebrated victory in the decade-long fight to protect Old Saybrook's Preserve, we joined local groups to save the Oswegatchie Hills—prime riverfront land in East Lyme endangered by reckless development plans. Throughout 2015, we led the legal challenge to this environmentally devastating proposal, fighting the developers in the East Lyme Zoning Commission and Connecticut Superior Court. We also intervened in the administrative proceeding before the Federal Energy Regulatory Commission to oppose a fracked gas pipeline through critical watershed lands in Greater Hartford. In April 2016, Kinder-Morgan announced they were putting the proposal on hold; we are keeping a watchful eye to ensure it is not revived or does not return in a different form.

Message from the Treasurer

Fiscal year 2015 was a year of progress and challenges for Connecticut Fund for the Environment. We ended the year with a deficit of \$4,296. Seventy-six percent of our resources directly benefited our programs. In New York, our work to protect the western Long Island Sound and reduce its hypoxic dead zones led to filing suit against the County of Westchester and some of its municipalities in order to enforce the law governing the amount of pollution that is released into the Sound as the result of aging and leaking infrastructure. We also launched the Sound Health Explorer, an online tool that allows the public to easily understand the level of fecal bacteria and other pollution at their local beaches and harbors. In Green Projects, our funding to install green infrastructure in Connecticut cities nearly doubled from \$156,000 to \$309,000. In our Forest, Island, and Coastal Protection program, our work to protect Plum Island from a for-profit sale by the United States government drew significant attention and

will continue to be a focus for the next few years. We also undertook a campaign to help protect Oswegatchie Hills in East Lyme from development. Through a generous multi-year pledge, we were able to expand our Legal Program and add another skilled lawyer to our outstanding staff. We look

forward to continued growth in these programs and all our other efforts in the year ahead. For further details, please view our full financial statement at our website www.ctenvironment.org.
