ECOLOGICAL RESTORATION: THE ECOLOGICAL RESTORATION PROGRAM WORKS WITH NATURAL SYSTEMS TO CREATE OR RESTORE THE CONDITIONS FOR ECOLOGICAL AND HUMAN THRIVING AND RESILIENCE. THE PROGRAM DOES THIS BY REMOVING DAMS AND RESTORING FISH PASSAGE; INSTALLING GREEN INFRASTRUCTURE THAT EMPLOYS NATIVE PLANTS TO ABSORB AND FILTER STORMWATER BEFORE IT POLLUTES LOCAL WATERWAYS; RESTORES MARSHLAND AND CONSTRUCTS LIVING SHORELINES TO IMPROVE COASTAL RESILIENCE AND REVERSE MARSH LOSS, AND ENGAGES THE PUBLIC IN PROTECTING WATER QUALITY AND WILDLIFE THROUGH A ROBUST CLEANUP PROGRAM AND OTHER EDUCATIONAL AND VOLUNTEER OPPORTUNITIES. THE LONG ISLAND SOUND PROGRAM USES CITIZEN SCIENCE, EDUCATION, ADVOCACY AND ON-THE-WATER WATCHDOG ACTIVITIES TO PROTECT AND RESTORE THE HEALTH OF LONG ISLAND SOUND AND ITS WATERSHED.
